Re: **Review of Response to Resistance for 2022**

The purpose of this document is to provide an analysis of response to resistance that occurred in the year 2022 at the Clinton County Sheriff's Office.

For comparison purposes, the Clinton County Sheriff's Office had involvement in fifty-nine (59) documented response to resistance in the year 2021, thirty-eight (38) being in our corrections division and twenty-one (21) in our Law Enforcement Division. In 2022 the Clinton County Sheriff's Office had involvement in fifty-five (55) documented response to resistance thirty-four (34) being in our corrections division and twenty-one (21) in our Law Enforcement Division. The Corrections Division had a slight decrease of incidents, while the Law Enforcement Division remained unchanged in its numbers in 2021.

Attached you will find spreadsheets that document in more detail the review of all response to resistance incidents reported.

In reviewing officer's actions during these response to resistance it is our opinion that officer's acted within the policy guidelines of the Clinton County Sheriff's Office.

Additionally, our office has completed a review of our policy and procedure pertaining to response to resistance and do not feel any changes or updates are needed at this time.
